C. Verifying Taxable Income

If the student or spouse will file a 2022 IRS income tax return, verification of that income can be provided when the student and/or spouse offer consent and approval for access, disclosure, and use of Federal Tax Information (FTI) on the FAFSA. If the FTI process is used, in most cases, no further documentation is needed to verify 2022 income information. If 2022 income tax return information is unavailable or FTI could not be used, the student can provide a signed copy of their 2022 income tax return and all applicable schedules, or a 2022 IRS Tax Return Transcript.
